#### **Terms**

- 1. All coaching/teaching fees are payable monthly in advance by no later than the last working day of Each Month.
- 2. No Water Safety/Learn To Swim/Coaching bookings can be confirmed for the new month until full payment and settlement of coaching and teaching fees are paid in full, further we reserve the right to deny our coaching services and to allocate your booking space and time to another swimmer if fees are not settled by due date.
- 3. We accept payment via EFT or Direct bank deposit only. When making payment please use the name as it is reflected on the invoice as your reference so funds can be accurately allocated. EG. Reference **SWIMMERS NAME** (as indicated on invoice).
- 4. Invoices will be automatically generated and mailed on the 25<sup>th</sup> of each month.
- 5. 2 months written notice is required should you wish to cancel the agreement for any reason and this should be mailed to <a href="mailto:neptuneaquatics@mweb.co.za">neptuneaquatics@mweb.co.za</a>. WhatsApp and text message will not be accepted.
- 6. Accounts will continue to be generated and payment expected until written notice has been received. All legal and recovery costs for overdue accounts including interest will remain the responsibility of the Swimmer/Parent or Legal Guardian.
- 7. Lessons or swimming sessions missed cannot be carried over for credit.
- 8. There is no swimming on Public holidays unless requested by the Head Coach.
- 9. Swimming lessons for December will be for the first 3 weeks and the last 3 weeks for January. All swimming fees for December and January are due payable.
- 10. Our annual swimming fee increase will be the 1st of January each year.

#### **Coaching and Teaching rules**

- 1. No parents to interfere or on pool deck during teaching or coaching sessions.
- 2. It is the responsibility of all swimmers to ensure they correctly attired and have all the required training equipment at lessons.
- 3. We cannot take any responsibility for the safety or behaviour of swimmers at the conclusion of lessons. It is the responsibility of parents to ensure that the facilities rules are respected prior to and after lessons.
- 4. We have a "No Bulling policy" and the safety of all swimmers is our priority, we therefore reserve the right to remove any swimmer from the pool who we deem to be disruptive or putting the safety of any swimmer in jeopardy.
- 5. It is the responsibility of all swimmers and parents/Guardians to familiarise themselves with and abide by the facilities, FSA and SAA rules and code of conduct at all times.
- 6. Correct and complete club uniform is required at all club competitions.
